All applicants must submit a completed application form (online in the eLicense system -- see above) and pay the application fee of \$120.00.

If the notary does not know the signer personally, Connecticut law (see Section 3- 94a (9) of the Connecticut General Statutes in Appendix B) requires that the signer provide the notary with at least two forms of identification containing the individual's signature, at least one of which also contains a photograph or a physical description of the signer.
