How to Use Quotations in MLA Format (8 ed.)

Even if your quote is fewer than 4 lines, MLA style requires you to use blockquote format if there is a paragraph break in the middle of the text you want to quote. Doing this preserves the paragraph break. When quoting more than one paragraph, indent the first line of any new paragraph an additional.25 inches (0.64 cm) from the left margin.

The first line of the excerpt should not be further indented, unless you are quoting multiple paragraphs—in which case the first line of each quoted paragraph should be further indented 0.25 inches. As should the rest of your paper, a block quotation in MLA style should be double-spaced.

Nor should you include any note numbers or parenthetical documentation from the original source, as noted in our post on what you can omit when quoting sources. If you wish to tell your reader the source of the quotations, you can provide the information in a single footnote or endnote at the end of the passage.

Formatting Quotations in MLA Style - Manuscriptedit

In-text MLA quotations typically include the author's last name and page number. If no page number is available, just include the author's last name. You can do this either in the text of the sentence that precedes the quote or in parentheses after the quote. Examples (from MLA Purdue OWL):

In general, MLA style does not use hyphens after "non," "co," "pre," and other prefixes and "off," "on," and other prepositions when forming a compound word. When deciding whether or not to hyphenate a compound word, follow the above guidelines and check the word in question in this manual.

For quotations of fewer than 40 words, add quotation marks around the words and incorporate the quote into your own text—there is no additional formatting needed. Do not insert an ellipsis at the beginning and/or end of a quotation unless the original source includes an ellipsis.

Punctuation marks such as periods, commas, and semicolons should appear after the parenthetical citation. Question marks and exclamation points should appear within the quotation marks if they are a part of the quotation but after the parenthetical citation if they are a part of your text.

APA Style: Handling Quotations, Citations, and References

There are two types of quotation marks: 'single' and "double". Which one to choose generally depends on whether you are using American or British English. The US convention is to use double quotation marks, while the UK convention is to use single quotation marks.
