On the completion of investigation, the police are required to follow certain procedures as laid down in Section 169 of CrPC till Section 173 of CrPC. In conducting an investigation, the investigator should pursue all reasonable lines of enquiry, whether these point towards or away from the suspect (Code of Practice to the Criminal Procedure and Investigations Act 1996 s.3.5). What is reasonable in each case depends on the particular circumstances.
